CONTEST RULES "Have Your Say"

1. CONTEST PERIOD

The "Have Your Say" contest is held by Groupe Promutuel Fédération de sociétés mutuelles d'assurance générale (hereinafter the "Contest Organizer"). It runs **from Wednesday, January 1, 2025, at 00:01 a.m., to Wednesday, December 31, 2025, at 11:59 p.m. EST** (hereinafter the "Contest Period").

2. ELIGIBILITY

This contest is open to all Quebec and New Brunswick residents of legal age in their province of residence **at the date of the draw** who receive an email invitation to complete an online questionnaire about their experience with Promutuel Insurance. Only those who receive the email invitation are eligible.

Employees, directors and officers of the Contest Organizer, its member mutual associations or any other entity forming part of the Contest Organizer, as well as persons with whom such persons are domiciled are excluded from participating.

3. HOW TO ENTER

No purchase required. To enter, eligible entrants must answer the satisfaction questionnaire received by email and return it during the contest period.

By completing and submitting the satisfaction questionnaire, eligible entrants will automatically be entered in the contest and be entitled to one (1) entry, **without any obligation**.

4. <u>PRIZE</u>

In total, five (5) prizes will be awarded. Each winner will receive \$500 in cash (cheque in Canadian dollars) for a total prize value of \$2,500.

5. HOW PRIZES ARE AWARDED

The five (5) winners will be chosen by random draw from all eligible entries received during the time periods below.  For questionnaires received between October 12, 2025, and December 31, 2025, 11:59 p.m.

The odds of winning depend on the number of eligible entries received at the time of the draw. A single entrant cannot be declared a winner more than once during the contest period.

6. DECLARATION OF WINNERS AND AWARDING OF PRIZES

To be declared a winner, the entrant selected must:

- A. Be reached by telephone or email within three (3) business days of the draw. If the selected entrant cannot be reached within three (3) business days of the draw, they will be disqualified and another draw will be held:
- B. Confirm that they are eligible and that they meet the other requirements of the rules;
- C. Correctly answer a mathematical skill-testing guestion asked over the phone or via email, without assistance and in the time allotted.
- D. Sign the declaration and waiver of responsibility form (hereinafter the "Declaration Form") sent to them by Promutuel Insurance and return it to the Contest Organizer within ten (10) business days of receipt.

The winners will be contacted to arrange for delivery of the prize. Prizes will be sent to the winners according to the terms and conditions to be communicated to them by the Contest Organizer.
